If it is determined that I am ineligible or eligible for less subsidized loan funds than requested C-GCC WILL NOT automatically process an unsubsidized loan for me. ***I understand that in order to access unsubsidized funds, the unsubsidized box above MUST be checked, indicating that I want them.*** I understand that loan amounts are subject to change based on my enrollment or receipt of other financial aid.
